

OGD UPDATES, & OTHER AIRPORT EVENTS



On October 1st, 2022 the OGD Airport will officially suspend some of the airline / TSA SIDA restrictions.

This will allow you the following:

1. If you are badged for the AOA and have successfully completed the driver's airport safety training, then you may drive or walk through the SIDA. Please see the photo below to see the preferred path. The Driver's Safety Brochure can be found on the OGD Airport's webpage or by following this link:

2. For those Bickering Sisters Restaurant guests, you can fly into OGD Airport, taxi your aircraft into the south side of the SIDA, park your aircraft, and walk into the restaurant to have a meal. Use the pedestrian turnstile north of Mountain Valley FBO to exit the AOA and to walk to the restaurant. Use the entrance on the west (rear) of the terminal building. This entrance will remain open during the construction, while the east front entrance will be closed.

3. The EAA's Young Eagles program will utilize the SIDA for their aircraft rides on Saturday October 15th, 2022 from 8am to 11am. This will include the SIDA and the TSA passenger holding room. Come tour the area before the construction, so that you can compare when the terminal expansion is completed.

Please keep the following things in mind:

A. This is temporary. It is anticipated that the airline operations will return to OGD between April & June in 2024.

B. We are working on some temporary ground markings for aircraft parking for restaurant guests, but there is a limited amount of space for approximately seven (7) small sized aircraft, such as a Cessna 210. If a twin engine aircraft with a wider wingspan parks, this may limit this area to less than seven.

C. Use of this aircraft parking area is "first come, first served" and use is at your own risk. This is simply because I cannot anticipate the size and type of all aircraft that could use this area. Use caution and watch for pedestrians. Aircraft parking in this area would be limited to four hours.

D. The northside of the SIDA will become a fenced-off construction site with the beginning of the OGD Terminal Expansion. Please note the red hashed lined area on the photo below. Project

light demolition will begin about mid-October and the heavy demolition should begin the first week in November. You can follow this project from the OGD Airport's project webpage at the following link:

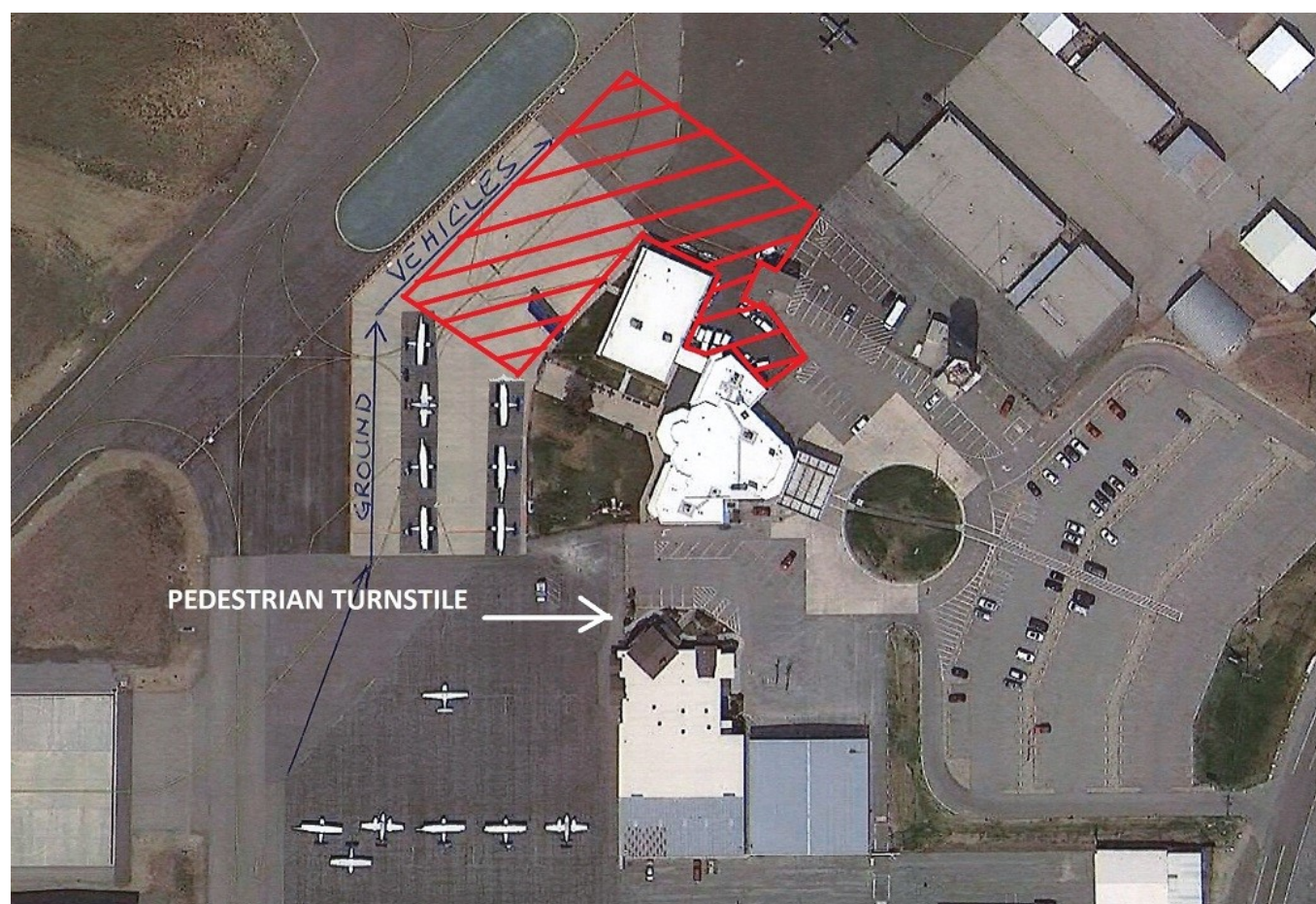

E. If you do not have an OGD Airport AOA Badge, use the one-way pedestrian turnstile shown in the photo below to exit the ramp area. The restaurant can give you a temporary badge to gain access back to your aircraft. The temporary badge will give you access to the card-swipe pedestrian gate next to the pedestrian turnstile between the terminal building and Mountain Valley FBO. Please return the temporary badge in the drop box on the fence once you have entered the AOA. The temporary badge will be disabled if you keep it, so please return it to the drop box, so it can be issued to the next pilot.

F. Bickering Sisters will remain open during all of the terminal building construction. The restaurant is open seven (7) days a week from 9:00 am to 3:00 pm. Please continue to support the Airport restaurant.

G. STAY OUT OF THE MOVEMENT AREA without Air Traffic Control Tower's clearance. While some of the TSA restriction will be suspended. FAA Airport Safety Standards, under FAR 139, will be strictly enforced. Safety is paramount. Do not cross the hold short markings without ATC clearance.

H. The SIDA markings will remain in place during this process. The paint used to place the SIDA redline on the concrete is quite expensive to remove and to repaint.



Lastly, the OGD Airport Offices will be vacated from the terminal building around the middle of October. Badging (Sati) and Leases (Angel) will be relocated to the old airport fire station directly north of the terminal building. The Airport Manager's office, the office for the ARFF firefighter / fire & safety inspections, and the Airport Project Coordinator's office will be in the mobile office unit / mobile home that is nearest to the terminal building on the north side. The other trailer along the fence is for the contractor doing the terminal expansion, Stacey Construction.
