 - v. **Consumer Price Index Source Amendment.** Proposed Ordinance 2015-28 amending the Ogden Municipal Code by amending Subsection 4-6-1.B.19; Subsection 4-6-1.B.20; and Section 9-1-6 to revise the source information for the Consumer Price Index adjustment relative to sanitary sewer, storm sewer, water, and refuse utility charges. (*Ordinance adopted, vote: 7-0*)

 - a. **Transportation Funding – HB362 Local Option Sales Tax.** Proposed Joint Resolution 2015-15 supporting the HB362 (2015) authorized 0.25% local option general sales tax dedicated to transportation, encouraging the County of Weber to submit the proposal to voters in November 2015, and encouraging voters to support the proposal. (Joint resolution adopted, vote: 7-0)
